VENDOR INFORMATION

Insurance: Each vendor is required to have a commercial general liability insurance policy if you are providing an onsite service. ***Only if you are providing an onsite service in direct physical contact with people. (Ex: Food, Massage, Tattoo, etc.)***

What's required: Proof of \$1,000,000 liability insurance naming the DOUGLAS COUNTY, THE PORCH MOVEMENT (two separate entities) as additional insureds, each with a separate certificate.

Vendors agree to provide their own table, chairs, shade and supplies. Vendors must properly secure their canopy/popup with legal canopy weights, sandbags or 5 gallon water buckets with locking lids. Twenty (20) pound minimum per each canopy. No cinder blocks or bags with rocks will be allowed to secure the booth. The fire marshal does walk through the event to inspect for safety.

Vendors must prepare to bring their own generator.

Vendors agrees to use Official Marketing Materials provided by The Porch Movement while advertising for the event.
